Abstract:

The Onondaga County Municipal Parks and Protected Open Space geographic dataset was created by the Syracuse-Onondaga County Planning Agency. The shapefile consists of polygon features representing most State, County, and local municipal parks in Onondaga County. The dataset is a direct extract of properties selected from the Onondaga County Parcel File. Although researched extensively from a variety of sources, including tax records, municipality websites, and comprehensive plans, this file is not intended to be a complete inventory of all public parks in the County. Attributes describing each park's name, location, owner, and classification are included.

Suitable for use in a GIS database to display, locate, and query public municipal parks and protected open space in Onondaga County.

Generally topologically clean. A few "slivers" resulting from minor gaps in the original Onondaga County Parcel File may exist within some municipal park polygons. While every effort has been made to remove many of these inaccuracies, some may still exist in the file. The precise location of park boundaries can only be confirmed by referring to the actual tax parcel information provided by the Onondaga County Department of Real Property Services.

Completeness_Report:

Shapefile consists of polygon features representing parcels of land included in State, County, and local municipal parks in Onondaga County as of mid 2020. This dataset was originally created from a direct extract of selected properties from the Onondaga County parcel file joined to the

Onondaga County Real Property Database. Any inaccuracies or omissions that may be included in the Onondaga County Parcel File or the Onondaga County Real Property Database may be reflected in this dataset. As a result, this shapefile should not be considered a complete representation of every public park in Onondaga County. This file is updated as needed (whenever previously omitted or newly created parks are brought to the attention of the Syracuse-Onondaga County Planning Agency).

The Onondaga County Municipal Parks and Protected Open Space shapefile was created as a direct extract of individual properties selected from the Onondaga County Parcel File and the Onondaga County Real Property Database. These properties were researched by SOCPA staff from a variety of sources including tax property records, municipality websites, hard-copy maps, and municipal comprehensive plans. Attributes were added to each property describing the park name, location (town or city), owner (municipality), and class (for cartographic organization). Using the NAME attribute, the shapefile was "dissolved" in ArcMap to form a single record for each park. Some minor post-processing was done on-screen in ArcMap by SOCPA staff to ensure accuracy and completeness.
